LETTER FROM THE EXECUTIVE DIRECTOR

Working at the hub of our climate action network is humbling as it is inspiring. Together, we challenge the most powerful interests of the industrial age. The consequences of failing are almost too grim to contemplate. In facing this most impossible of missions it is the vision, creativity and tenacity of our own people that astonishes me every day. And it is the energy of our members that lifts up and propels the Network Support Team forward.

This year our major focus was Repowering Australia with clean, affordable energy. Our federal government may believe they can keep Australians fearful of the energy transition but CANA members know otherwise. We are building a movement as diverse as it is unified. Unionists, farmers, people of faith, people of colour, country-dwellers and city folk - all understand the simple, irrefutable fact that repowering with clean energy will make a better life for us all.

Earlier this year I explored ideas of climate justice with manufacturing workers from some of Australia's most energy intensive workplaces. Far from resisting the transition they wanted to turbo-charge it and make sure nobody is left behind. How? By using the power of government to give every household access to free clean energy paid for through a medicarestyle levy - an idea echoed in Getup's proposed <u>Household Clean Energy</u> <u>Guarantee.</u>

I attended the Voices for Power conference in Western Sydney where 141 leaders representing the Filipino, Middle Eastern Christian, Jewish, Vietnamese, South Asian, Muslim and Pacific Island communities endorsed a Roadmap for Clean and Affordable Energy, a vision of energy justice that echoes the <u>Repower Australia Plan</u>.

Collectively our network had hundreds of thousands of conversations with voters in the lead-up to state elections and by-elections. Time and time again we heard that Australians are hopeful and embracing the energy



transition. They understand we must must stop Adani, move beyond coal and Repower Australia.

None of this is happening by chance. It is happening because CANA members support each other to reach deeply into their own community and empower the vision and leadership that exists there. For us in the Network Support Team, it is an extraordinary honour to support you in doing so, and we look forward to redoubling our efforts in the year ahead.

As the saying goes, 'to change everything we need everyone.' Whether your organisation is a founding member of CANA or just starting to contemplate how you can contribute to climate action we would love to hear from you. Please get in touch to discuss how we can best work together, and join our network because it is only together we will have the strength to prevail.

I would particularly like to thank Duncan Jinks, who steps down as CANA Treasurer after filling this essential role for another term this past year, and whose calm leadership is a great asset to our organisation.

As we evolve, so too does our strategy to ensure our collective impact is truly greater than the sum of our parts. We have heard clearly from members that while they are keen for us to maintain our important relationship-building work, they are also interested in how CANA can inform and support the continued evolution of network strategy. This is work we began this year, and will take forward with vigour in the year ahead.

BETTER STRATEGY

The climate movement is strongest when different approaches combine towards the same goals. We facilitate members to collaborate and align their strategies to maximise impact.

The last year has seen renewable energy boom across Australian rooftops and farmland, in businesses and communities. We must leverage this momentum to make the transformation faster and fairer. That's why we have invested heavily in Repower Australia, a powerful network of campaigns to **expedite Australia's transition to 100% renewable energy and close all coal-fired power stations by 2030.**

The Repower Australia collaboration was founded by CANA members Solar Citizens, Australian Conservation Foundation, the Nature Conservation Council of NSW, Environment Victoria and 350.org and grew over the last year to include Greenpeace, GetUp!, Environmental Justice Australia, the Australian Youth Climate Coalition, Community Power Agency and many others.

FACILITATING COLLABORATION

We convene the **Repower Caucus** where members build shared commitment, exchange campaign updates and spark new joint initiatives. Expert and project-based working groups progress shared work outside the caucus.

In October we hosted the Repower Retreat to build relationships between senior organisers, strategists and campaigners from thirteen members leading work to expedite Australia's transition to 100% renewable energy.

CRAFTING BETTER ENERGY POLICY

We convened a working group of seven CANA members to develop and promote five actions the next federal government must take to Repower Australia with clean energy:

- make Australia a renewable superpower,
- ensure affordable clean energy for all,
- plan the orderly closure of coal power stations with a just transition,
- enforce national air pollution standards that protect our health
- align climate and energy policy.



These policy priorities and many more are outlined in the <u>Repower Australia</u> <u>Plan</u> blueprint that shows the transition to 100% renewables is 100% doable and 100% better.

TACKLING BAD POLICY HEAD-ON: THE NATIONAL ENERGY GUARANTEE CAMPAIGN



CANA members Greenpeace, Environment Victoria, GetUp!, Australian Youth Climate Coalition, the Australian Conservation Foundation, 350.org, Farmers for Climate Action, Solar Citizens and Uniting Church campaigned to improve the NEG, pushed state governments to utilise their power to improve the policy, and built public pressure for stronger emissions reduction.

We coordinated a campaign to highlight and oppose the deficiencies of the Turnbull government's **National Energy Guarantee** (NEG). When it was initially proposed in October 2017, the NEG contained little detail on how it would lower climate pollution from the energy sector. Over the following ten months CANA members shifted the policy and public debate to one of whether the NEG would actually reduce emissions.



CANA played a critical role in driving a collaborative correction collaborative campaign on the National Energy Guarantee. GetUp! increased our impact by aligning strategy with other CANA members and amplifying key tactics. Without the strategic support and coordination of the Network Support Team we would not have seen the outcomes that we did from the Victorian, ACT and Queensland Governments".

FOSTERING ACTION FOR ENERGY JUSTICE

To nurture collaboration with the social sector and unions working with low-income and disadvantaged people, we convened a Clean Energy for All Roundtable in March. Twenty delegates from the Sydney Alliance, Australian Youth Climate Coalition, Seed, National Union of Workers, the Uniting Church, NSW & QLD & Australian Councils of Social Service, GetUp!, Australian Conservation Foundation, Community Power Agency, Environment Victoria, Public Interest Advocacy Centre, The Brotherhood of St Laurence, and Solar Citizens attended the day-long training.

The roundtable selected three **opportunities** to drive a fairer transition to clean energy: alignment on an energy justice platform for the next federal election; minimum energy performance standards for rental properties; and solar power for renters and public housing. The Roundtable laid an excellent foundation for the energy and climate justice caucus we will launch in 2019.

A NEW STORY ABOUT THE ENERGY TRANSITION

We worked with international campaigns and digital communications expert Jason Mogus to develop a new story and digital engagement platform for engaging new audiences in the energy transition.



<u>The Repower Australia website</u> and Repower Australia Plan were launched in March by Bill McKibben, international author, educator, environmentalist and co-founder of 350.org.

"Upgrading Australia to clean energy creates a better life for everyone. It will help us control our energy bills, bring better jobs, cleaner air, and healthier communities. And protect us from extreme weather due to climate change.

But we're getting ripped off! To protect their profits, a few big polluting energy companies and the pollies in their pockets are locking us into old technologies they control. Their love of money is making people sick and putting our whole world at risk.

We can take back control. That means clean energy for all, owned by people and communities. We have to fight for solutions that help people, not just big polluters. We need to go beyond coal, support workers to make a just transition, and public money for clean energy. This will help us control our energy bills, our communities, and our future.

Upgrading our energy system is easier than you think, and it's already happening. Solar and storage are cool, cheaper than coal, and reliable, today. Australia's people and companies are leaders. Stopping climate change helps everyone. Let's put renewables everywhere!"

We write and share Repower-related stories and posts from Network members on our <u>Repower facebook page</u> (@repower) and <u>Repower</u> <u>Australia twitter page</u> (@100renew), **extending their reach** to an additional 12,000 fans and 8,000 followers, respectively. These shared stories reflect our growing movement.



STRONGER RELATIONSHIPS



We bring members together to listen, share, strategise and build the functional trust that underpins powerful and effective collaboration. Retreats, caucuses, working groups and trainings provide accessible opportunities for the different needs of members.

BUILDING TRUST BETWEEN LEADERS

CEOs attending our **biannual residential retreats** connect with existing and new leaders in the climate movement. They **share challenges and ambitions** and develop big picture strategy. This year's retreats resulted in coordinated campaigns to defend civil society freedoms and featured **insightful presentations** on big organising, how to talk about economics and shifting attitudes to coal and climate.

WOMEN BUILDING POWER TOGETHER



We convened two meetings for women CEOs to discuss and organise around their unique issues and ideas in person. A women's **mentoring** program has been established, discussions have commenced to analyse **gender pay inequality** in our movement, and all Network CEOs have been asked to sign a pledge to only appear on **gender-balanced speaking panels**.

We hosted two cross-sector events for women in the environment, union and social movements to gain knowledge, build relationships and share skills. In December we partnered with 350 Australia and the Community and Public Sector Union to host speaker May Boeve, co-founder of 350. International. In March we partnered with 350, Nature Conservation Council of NSW and APHEDA to host speaker Ellen Dorsey, Executive Director of the Wallace Global Fund, a private foundation focused on progressive social change. Women attendees **highly valued discussions** on philanthropy and women's leadership, and they committed to networking in the future.



CONNECTING ACROSS THE COAL & GAS MOVEMENT

The **Beyond Coal and Gas Jamboree** held on the Sunshine Coast in Queensland in May 2018 was a fantastic opportunity to communicate the plan for Repower Australia. We facilitated six workshops about renewable energy, and five about the orderly closing of coal-fired power stations with a just transition for workers and communities - all of which attracted 20-40 participants.



We sponsored nine people and encouraged all Network members to attend the 3-day Jamboree. A third of the 365 attendees were CANA members. A highlight was the opening plenary led by Aboriginal and Torres Strait Islander peoples as well as three plenary speakers strongly focusing on Repower.

GREATER CAPACITY

SUPPORTING LOCAL ACTION

In 2017, we launched the Repower Australia Small Grants Program to support grassroots action to expedite Australia's transition to 100% renewable energy. Funded by the Robert Hicks Foundation, we awarded over \$134,850 to 25 projects developing the capacity of local leaders and building a deeper community understanding of the need for renewable energy.

Our grant program leverages the knowledge of the network through an advisory committee of members & allies connected to grassroots climate action. We also provide coaching and advice on all applications and projects to increase the impact of each group.

SCHOLARSHIPS

Thanks to the Change Agency we were able to offer two full and two partial scholarships in the 2018 **Community Organising Fellowship**, an intensive 6-month program for social and climate justice campaigners. We awarded them to applicants from the Northern Territory and United Voice to encourage new and diverse campaigners into the climate movement. After a successful experience, United Voice have enrolled another campaigner for the 2019 Fellowship.

Thanks to Australian Progress we supported two young climate activists from our Network with scholarships to the **FWD + Organise** conference in November 2017.



TRAINING



In October we co-delivered **Volunteer Management Training** with Kristyn Crossfield from Reveille. 350.org, Australian Youth Climate Coalition, the Nature Conservation Council of NSW, Greenpeace, Solar Citizens and GetUp! attended the day-long training to understand values-based leadership, practices to keep a great volunteer team and management of results.

We collaborated with National Union of Workers and APHEDA to deliver **climate justice training to 25 manufacturing union delegates** who developed a list of areas for working climate and energy justice into union bargaining and campaigns.

We co-delivered climate campaign training for five Pacific Union officials with the Public Services International and 350.org. 350.org has



subsequently been invited to conduct training on climate campaigning at the upcoming Fijian public sector event.

In December we partnered with Unions NSW, the Community and Public Sector Union and Australian Progress to host a **forum at Trades Hal**l in Sydney for leaders and campaigners from a variety of progressive, cross-sector organisations. **Becky Bond**, author and political strategist, shared insights from the **distributed "Big Organizing"** program for Bernie Sanders' 2016 U.S. presidential campaign.

PARTNERING WITH FARMERS FOR CLIMATE ACTION

As part of our commitment to supporting new voices in the climate movement we are supporting Farmers for Climate Action (FCA) to organise a groundswell of climate action on the land and become a trusted and respected voice in the agricultural world and beyond. Throughout the year FCA hosted and contributed to events from Dowerin to Cooma and Mackay to Seymour including field days, candidate forums, town hall meetings and climate smart agriculture events. They regularly feature in media reporting on climate and agriculture, ensuring that the climate signal in the impact of extreme events is understood, that the importance of a clean energy transition is recognised and that the threat that extractive industries present to agriculture is clearly articulated.

ORGANISER DEVELOPMENT

We continued developing the network's growing number of climate organisers this year. Organisers took a leaf out of their own book, organising themselves into state OrgHubs in the Eastern states. Learning goals are determined by the cohort and have included sessions on topics such as the role of metrics, volunteer training materials and approaches to diversifying our movement. Victorian organisers enjoy regular social events with their union compatriots and both NSW and QLD organisers have had union and Sydney Alliance organisers attend meetings. This cross-fertilisation creates the opportunity for increased learning as well as conditions for future collaboration.

It is the **Public Fund Committee's** responsibility to monitor the fund to ensure that donation income is used appropriately. The **Finance Committee** evaluates the financial performance of CANA and ensures that financial resources are used appropriately in accordance with CANA's objectives and policies, the ongoing financial viability of the organisation, and also provides the Board with strategic advice on the fundraising plan. As at 30 June 2018, Finance Committee members were Duncan Jinks (chair), Simon Bradshaw, Kate Smolski, and Erwin Jackson.

The purpose of the **Legal, Governance and Employment Committee** is to ensure that the Board fulfills its legal, ethical and functional responsibilities through adequate governance, policy development, monitoring of Board activities, risk management, employment practice and Board performance. A TRIBUTE TO JEM BAMFORD

Jem joined the Network Support Team in October 2016. She brought a wealth of movement knowledge and experience from her years at the Australian Youth Climate Coalition. Jem approached her work as Campaigns Facilitator with intelligence and humility. She possessed a talent for both big picture strategy and attention to detail, a combination that alludes so many of us. Her key strength was her ability to read people, something usually not so developed in someone so young in years. Due to illness Jem finished working with CANA in October 2017. Tragically, Jem's illness took her from us in January 2018. Jem is deeply missed by her colleagues in the Network Support Team and her many friends and colleagues in the climate movement.



TREASURER'S REPORT

There are two main stories to CANA's financial performance over the 2017/18 financial year. The first is the commencement in earnest of our regranting program, through which we resource frontline climate action by CANA members and allies. The second is somewhat less exciting but no less important. 2017/18 was the year we began our transition from startup phase to a financially mature organisation, diversifying income streams whilst controlling costs.

Our budget grew significantly from the 2016/17 to 2017/18 financial year. Income increased by 51% or \$264,193. The main driver for this was our regranting program, which grew from only \$36,375 in 2016/17 to \$242,875 in 2017/18. In other words, 78% of our new income went directly to resourcing frontline climate action through grants and partnerships aligned with our core purpose. In total, regranting accounted for 32% of our expenditure in 2017/18.

At the same time expenditure on our traditional functions of convening and advising members contracted by 8% or \$42,685. We ended the year with a modest surplus of \$19,513, replenishing reserves after a deficit in 2016/17. Addressing this deficit explains the remaining 22% of income growth.

Three years since the organisation's "reboot," with the first two years focused on establishing runs on the board, 2017/18 was the year we began addressing our long term financial sustainability. We need to grow our income base by developing new income streams whilst continuing to demonstrate value to our existing members and donors. This year we took the first step in the journey with growth in philanthropic support generously provided by the Robert Hicks Foundation, The Sunrise Project and The Diversicon Foundation.


This was against the backdrop of the conclusion of seed funding generously provided by our five Core members. The reboot of "CANA 2.0" was enabled by a visionary two year pooled investment of \$250,000 per year by the Australian Conservation Foundation, Getup!, Greenpeace Australia Pacific,



The Wilderness Society and WWF Australia. In 2017/18 this reduced to \$185,000 and will reduce further to \$155,000 in 2018/19. Replacing this seed funding is a key financial challenge for the organisation which we began to address in 2017/18 and will continue in the year ahead.

We begin 2018/19 with a balance sheet of \$243,785 which represents approximately 6 months of normal operating costs for CANA, a level with which the Board remains comfortable.



YEAR ON YEAR COMPARISON


